Identifying information may be removed and this de-identified information used for future research without additional informed consent from the participant.

8. Compensation for Injury

If you suffer an injury that requires any treatment or hospitalization as a direct result of this study, the cost for such care will be charged to you. If you have insurance, you may bill your insurance company. You will be responsible to pay all costs not covered by your insurance.
